Dr. Krishnapriya Mohanraj welcomed all the members and briefed about Bombay College of Pharmacy (BCP) through PPT presentation.

He also informed that DTE has not released the grant since 2017-18 which got accumulated and till date almost 2Cr 34 lacs is pending from DTE against grant. He also said that from expenses, some are admissible by DTE, and some are not . DTE asked few documents which are getting ready and file will be submitted to them at the earliest.

Dr. Pradeep Kamthekar willingly agreed to help for the follow up if required from University of Mumbai to receive pending grant.

Mr. Nitin Maniar added that due to shortage of teaching staff Management has appointed 6 faculty members whose salary will be on 7th pay basis which is additional burden.

Government will release 7th pay arrears who are on DTE pay roll but 10 % of the amount will be borne by Management because DTE will release 90% amount.

He further added that Pan Card of BCP will be surrendered and everything is now under the PAN card of The IPA-MSB (Trust)

BCP tried to get the grant from RUSA, Delhi as informed by Dr. Krishnapriya Mohanraj but accreditation of NAAC is required for the same. Dr. Pradeep Kamthekar will put word to RUSA and find out the details.

She further informed that BCP has not received grant for autonomy (around 10 to 20 lacs). Gazette mentions that all autonomous institutes will receive financial aid but guidelines by UGC mentions that grant will be paid only for Arts, Science & Commerce colleges.

Dr. Pradeep Kamthekar suggested to get associated with autonomous colleges. He further informed that Shivare sir is in-charge of Autonomous college association.

He suggested to have one meeting in 1st week of February 2021 with Pro Vice Chancellor and Dean Academics to discuss on pending issues.

Dr. Pradeep Kamthekar suggested to start various courses under autonomy as per industry requirements.

He suggested to start certificate courses related to medicines, person working in pharmacy and also course related to finance or B.Com with actuarial studies.

He suggested to start courses as per situation & industry demand to cover the deficit. Prof Krishnapriya Mohanraj mentioned that Pharmacy comes under the purview of faculty of Technology and it may be difficult to start courses not related to Pharmacy. Dr Khamtekar stressed that great importance is now given to interdisciplinary learning and Science students do very well in commerce subjects. Prof Krishnapriya Mohanraj mentioned about the ongoing 3 months (96 hours) part time certificate course in Data Analytics in collaboration with Navigo Analytix which is interdisciplinary and the planned part time online two month certificate course (30 hours) with Pharmaliterati on IPR on NDDS and specialty products. Prof Krishnapriya mentioned that it was difficult to get adequate students for the courses and hence to get regular income through fees, B Pharm- unaided was proposed and BCP is starting with 40 unaided seats after getting all requisite approvals.

UG, PG and PhD fees were reviewed. Dr Khamthekar requested to attach FRA guidelines for adhoc fees for B Pharm.

Dr. Krishnapriya Mohanraj informed that interviews for PhD are scheduled on 27th Jan 2021. She informed that as per University mandate each research guide can take only 8,6, or 4 students depending on faculty cadre. In BCP, the number of PhD research guides have reduced from 13 to 7 and due to shortage of guides, we cannot fill all 35 seats of PhD.

Dr. Pradeep Kamthekar suggested to find out if guide from other institute can register in BCP. Prof Krishnapriya
