

	As per PCI, Students should have minimum 80% attendance in theory and practical. Overall attendance will be considered to check eligibility for appearing for examinations (not subject wise). The students need to be oriented about the attendance requirement during the induction program. Students should check the attendance on portal regularly and within 48 hrs. should report to concerned faculty in case of any discrepancy. The attendance committee (or academic committee) will look into the overall attendance of students. Institute of Chemical Technology has attendance committee to consider the same.	
	At Institute of Chemical Technology, the students need to have minimum 75% attendance in theory and practical to be eligible for appearing in examinations. If a student falls sick, is hospitalized or has major emergency and produce a medical certificate, then consideration may be given to student with attendance under 75% on case to case basis (65% attendance may be considered then).

The examination pattern comprises of Internal assessment (25 marks) and End Semester exam (75 marks) for theory. The internal assessment includes Continuous mode of assessment (4 marks), Academic activities (3 marks), Student Teacher interaction (3 marks) and sessional exam (15 marks).

Student Teacher interactions should effectively improve students' confidence and engagements in course and other activities conducted at the institute.

Two sessional exams will be conducted each of 30 marks. The marks will be averaged and calculated out of 15.

The University of Mumbai rules and regulations for B. Pharm (CBCS) will be continued for 2nd, 3rd and 4th year B. Pharm.

The admission of diploma and transfer students to direct second year B. Pharm (Sem III) is conducted by DTE. The institute should communicate to DTE to not allocate transfer candidates after college has received autonomous status in 2019.

In case the students follow unfair means during examinations, penalty may be given to students for repeat exams or one credit can be lowered from final credits or student may be debarred for one year. The examination committee will take the decision for the same.

At Institute of Chemical Technology, students are given a Student Diary. It includes rules & regulation and academic calendar along with all required information for students.

The extracurricular activities committee will decide and award grade or extra credit to students for participation in various activities including Co-curricular and College Social Responsibilities activities throughout the year.

The institute will follow UGC plagiarism related regulations

The program committee will make necessary arrangements for practice school of fourth year B. Pharm students in semester VII as per PCI requirements.






