Applications are invited from NET/GATE/GPAT qualified candidates for two Junior Research Fellowship positions for the project entitled "NATIONAL FACILITY FOR RESEARCH AND TRAINING IN INTEGRATED ANALYTICAL STRATEGIES FOR DISCOVERY, DEVELOPMENT AND TESTING OF DRUGS, PHARMACEUTICALS AND NUTRACEUTICALS". This project is sponsored by Department of Science and Technology (DST) under Drugs and Pharmaceuticals Research Programme (DPRP) with the total cost of Rs. 587.01 Lakhs, at Bombay College of Pharmacy under the supervision of **Dr. Vaishali Shirsat and Dr. Krishnapriya Mohanraj**. A fellowship of Rs. 32,500 p.m. (inclusive of HRA) will be paid to the selected candidates for one year. Subsequently, the fellowship may be revised and/or renewed for a further period of two individual years based on the satisfactory performance of the candidates and subject to approval by DST. The total duration of the fellowship will be limited to three years.

Candidates with M.Sc./M.Tech./M.Pharm. degree (or equivalent) from UGC/AICTE/MHRD recognized institutes with a knowledge of Pharmaceutical Analysis and a strong interest in Herbal analysis, Impurity profiling, Bioanalysis & Therapeutic Drug Monitoring (TDM) and Drug metabolism & Pharmacokinetics are encouraged to apply.

Those who have submitted their Master's thesis and are awaiting their viva-voce exam may also apply; however, if selected, the candidate must secure his Master's degree quickly. Selected candidates may be given the opportunity to enrol for the Ph.D in Pharmaceutical Chemistry program of University of Mumbai through Bombay College of Pharmacy, one under respective investigators, subject to availability of seats and fulfilment of all terms and conditions stipulated by the University and the College. Application (hard copy) should be received at Bombay College of Pharmacy on or before 10th April 2017, 4:00pm closing time. Candidates are required to submit a covering letter giving all contact details (Address, E mail id, Mobile number), curriculum vitae and attested copies of their valid certificates/letters/documents in support of their qualification and work experience. **Applicants are advised NOT to send any original certificates.**
