	Mohanraj, the minutes of meeting were formally approved and confirmed.

Academic year 2019-	and Dr Vaishali Dixit presented the result analysis of the academic year 2019-
2020	2020 of their respective departments.
	All have informed that the results of First Year B.Pharm and Second Year
	B.Pharm were from 85-90%. Less that 90% results were attributed to
	introduction of basic subjects, delays in admission process and difference in
	the examination pattern post autonomy. The result analysis of Third Year B
	Pharm and Final Year B Pharm and M Pharm Sem I was 100%. However, the percentage of students securing distinction was low. Prof. Krishnapriya
	Mohanraj suggested that distinction percentage can be improved by taking
	class test and assessing before the mid semester and end semester
	examinations.
	Dr Ujwala Shinde and Dr Alka Mukne raised the discrepancy in the
	distinction/first class/second class and pass class analysis. Dr Krishna lyer and
	Dr Vaishali Shirsat said that the analysis should be as O/A/B/C/D grades and
	not as percentage. Dr. Dipti Gatne was informed to resolved the discrepancy
	on the portal. Dr Dipti said that she has been coordinating with I-Web for result
	analysis program and it will get solved by first week April 2021. Prof.
	Krishnapriya suggested the program should be validated at test site before
	implementation. Prof. Krishnapriya Mohanraj further requested that the result
	analysis of allied subjects should also be presented. Dr Ujwala said the
	responsibility of result analysis of allied subject presentation should be taken
	by the departments other than Pharmaceutics and Pharmaceutical Chemistry
	as both the departments have 7 subjects per semesters including practicals.





360-degree Feed back Dr Alka Mukne said that data regarding 360 degree feedbacks needs to filled in AICTE portal. Dr Alka further emphasized that delays in filling could affect the self-appraisal and CAS of DTE faculty. Dr Ujwala furthermore said that in future the AICTE approval will also require the compliance of 360 degree. Dr Vaishali Shirsat said that for assimilate the students feedback, students have to log in on AICTE portal. Dr Shalaka informed that currenting the process of extension of approval is going on, once it gets completed the data uploading of 360 degree will commence. Dr Premlata commented that college should fix the deadline for completing the data uploading task on AICTE website as early as possible. Dr Alka said the details should be filled by admin staff on consultation with academic committee. Prof Krishnapriya Mohanraj said as uploading task is herculin to support all activities the management should provide nonteaching staff. Dr. Sivaprasad Sir requested the faculty members to put their requirements in writing to the Management and Dr. Nagarsenker was also of the same opinion. Prof. Krishnapriya Mohanraj agreed that all HODs should write to management for allocating/appointing additional support staff for compilation of data. Dr Dipti Gatne presented the policy documents to the committee members. In Ratification of Policies as per NAAC case of anti-ragging policy, Dr. Nagarsenkar pointed out that previous notice requirement board member names should be removed and Mrs Swati Pitkar said that notice board members names will be changed once policy draft is approved. Policy draft of Grievance/ SC/ST/Code of Ethics/Research/Plagiarism policy has been approved by members. Prof. Krishnapriya Mohanraj asked Dr Dipti to upload the mandatory polices and weblink for government scholarships on BCP website. Dr Dipti Gatne informed that as per UGC, there is a requirement of uploading of M Pharm and Ph D thesis along with plagiarism report on Shodhganga repositories. Ms Deepa Warrier suggested that student can upload their thesis on Shodhganga repository at the time of submission. However, the members are of opinion not to upload the thesis until the research was published in the scientific journal. Any other Matter Dr Vaishali Shirsat informed that while doing the marks entry on EMS portal the marks do not get saved unless and until the entire entry of marks is complete. Dr Dipti Gatne assured that the problem will be rectified. Prof Krishnapriya Mohanraj suggested that a calendar should be prepared for IQAC meeting, e.g., IQAC meeting shall be held every three months on third Saturday. Dr Ujwala Shinde asserted that the calendar will be prepared and circulated to all members.






