- These rules may be called the Principal or Director, Professor, Associate Professor, Assistant Professor and Workshop Superintendent in Government Engineering Colleges and Government Pharmacy Colleges (Recruitment) Rules, 2012.
- 2. In these Rules, unless the context requires otherwise,
 - (a) "AICTE" means the All India Council of Technical Education;
 - (b) "Directorate" means Directorate of Technical Education;
 - (c) "Government" means the Government of Maharashtra.
- 3. Appointment to the post of Principal or Director of Government Engineering Colleges and Government Pharmacy Colleges shall be made by nomination on the basis of strict selection on merit from amongst the candidates who.
 - a. are not more than 54 years of age;
 - b. possess the qualification and experience prescribed by the AICTE or relevant statutory body for this post from time to time.

- 4. Appointment to the post of Professor in various Engineering, Pharmacy, Non-Engineering disciplines and Master of Computer Application education in Government Engineering Colleges and Government Pharmacy Colleges shall be made by nomination on the basis of strict selection on merit from amongst candidates who.
 - b. are not more than 54 years of age;
- b. possess the qualification and experience prescribed by the AICTE or relevant statutory body for this post from time to time.
- 5. Appointment to the post of Associate Professor in various Engineering, Pharmacy, Non-Engineering disciplines and Master of Computer Application education in Government Engineering Colleges or Government Pharmacy Colleges shall be made by nomination on the basis of strict selection on merit from amongst candidates who,
 - a. are not more than 50 years of age;
 - c. possess the qualification and experience prescribed by the AICTE or relevant statutory body for this post from time to time.
- 6. Appointment to the post of Assistant Professor or Workshop Superintendent in various Engineering, Pharmacy, Non-Engineering disciplines and Master of Computer Application education in Government Engineering Colleges or Government Pharmacy Coffeges shall be made by nomination on the basis of strict selection on merit from amongst candidates who,
 - a. are not more than 35 years of age;
 - b. possess the qualification and experience prescribed by the AICTE or relevant statutory body for this post from time. to time.
- 7. Equivalence of suitable industrial experience with Doctorate of Philosophy or industrial research with Doctorate of Philosophy (Ph.
